March has been a long, hard month for the Band of Brothers. We have one ill member and lost three long time members. Kindly keep them in your prayers.

It is with great sorrow that we announce the passing of Brother R. Scott Emerson on March 5, 2022. Scott has been a member for the past 7 years and would have been 69 this coming March 30th. He was an Army veteran and an avid golfer (playing 6 days a week), who worked for the government in one of the US Security Agencies and the IRS in Knoxville, TN where he wrote books on tax law. Scott served as an advisor to the BOB on our 501 (c)(3) corporation. Additionally, Scott was our biggest benefactor who donated \$10,000 to our Scholarship Fund this past year. He is survived by his sister Nancy Miller, niece Rhonda Miller and great-niece Elisa Miller. Scott was a true gentleman who never had a harsh word for anyone ... he will be truly missed.

Another of our Brothers has travelled to Fiddlers' Green. On March 15, we lost Ron Moore. Ron was a US Army veteran who served two tours in Vietnam and one in Alaska. He was discharged as an Temporary Captain who initially functioned as a Radio Corpsman with HHC, lst BN, 41st Armored Division. Additionally, Ron graciously volunteered to cover the midnight shift on security detail for the two events when the Band of Brothers brought in the Moving Wall to Lady Lake. He is survived by this wife, Patti, his son Lonnie, a daughter, Step-children and Step Grand-children. He will be interred in the National Cemetery in Cantor, Georgia. Ron has been a member for the past seven years.

On March 15, we also lost Brother Frank Crane. Frank was a member of the Band of Brothers and a veteran of the U.S. Army. He is survived by his brother, Ralph Crane who






Cut-off for ticket sales is at **3:45 pm**. We have three (3) prizes each week pending the amount of funds collected.
